Site Requirement for Setting up CNG Station:

- The plot should have a clear and undisputed title for setting up a CNG station.
- For National Highway [NH] /State Highway [SH], the plot should be around **1500 Square meters** and having minimum frontage of **35 meters**.
- For city, the plot should be around **900 Square meters** and having minimum frontage of **30 meters**.
- No overhead power/telephone lines and underground Oil/Gas/Water Pipeline.
- Land should not be the part of right of way of government road, SH or NH road.

Interested parties should collect Application form comprising detailed guidelines of eligibility criteria & terms and conditions. The Application form is available at IRM Energy office, Tiruchirappalli.
