#### **Site Requirement for Setting up CNG Station:**

- ▶ The plot should have a clear and undisputed title for setting up a CNG station.
- ▶ The plot should be on main road (National Highway [NH] /State Highway [SH]).
- ▶ The plot should be approximately 1500 sq. mtr. in area, with a minimum frontage of 35 meters.
- ▶ No overhead power/telephone lines and underground Oil/Gas/Water Pipeline.
- Land should not be the part of right of way of government road, SH or NH road.
